## Section 6 Accidental Release Measures

### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flares in hazard area. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

For emergency responders: If specialised clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in for "For non-emergency personnel".

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air)

### Methods and materials for containment and cleaning up

Small spill: Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Use spark-proof tools and explosion-proof equipment. Dispose via a licensed waste disposal contractor.

Large spill: Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Use spark-proof tools and explosion-proof equipment. Dispose via a licensed waste contractor. Contaminated absorbent material may pose the same hazard

Use Gloves, Goggles, Boots and Breathing Mask. Small amounts do not need special measures. Clean up with water. For large spills remove all sources of ignition. Ventilate area. Absorb with an inert absorbent material. Avoid runoff into drains and sewers. All used and unused product should be disposed of in conformance with local, state, and federal regulations

## Section 7 Handling and Storage

Precautions for safe handling: Put on appropriate protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapor or mist. Keep in the original container or an approved alternate made from a compatible material, keep tightly closed when not in use. Store and use away from heat, sparks, open flame or any other ignition source. Do not reuse container. Wash thoroughly after use.

Conditions for safe storage: Store in original container protected from direct sunlight in a dry, cool and wellventilated area, away from incompatible materials (see Section 10) and food and drink. Do not store in unlabeled

Store materials tightly closed and away from sunlight, warm confined spaces, heat and open flame. Never weld on or near containers either empty or full. Secure all chemicals out of the reach of children.
